2020 Program Service Accomplishments People Making a Difference through Community Service, Inc. (PMD) promotes informed and responsible volunteerism by engaging individuals in meaningful, hands-on work that meets local needs and by helping charities and businesses develop their own, successful community involvement programs. Despite the covid-19 pandemic causing the cancellation of all in-person volunteer projects for 5 months and then limiting resumption due to state reopening policies, People Making a Difference directly helped 13 charities and their clients. PMD partnered with these charities to plan and to complete 13 productive, high quality service projects involving 154 motivated volunteers in-person, remotely, and virtually. PMD recruited 68 new volunteers who participated in the service projects described below. Together with 86 PMD volunteers who had participated in prior PMD projects, they gave 1,147 hours to complete needed work in 19+ communities. 85% (11) of the charities that PMD assisted had no staff dedicated to working with volunteers or relied on part-time staff, while the other 15% (2) received PMD assistance due to seasonal volunteer shortages and/or special needs. In 2020, PMD's community service program addressed the following issues: 39% Literacy (science, Braille) 23% Poverty/Hunger 23% Elders 15% Environment/Conservation (Continued on Schedule O, Statement 3)

The Anna Bissonnette House is home to 41+ elderly residents who were homeless or at-risk for eviction/homelessness.
