2023 Program Service Accomplishments People Making a Difference through Community Service, Inc. (PMD) promotes informed and responsible volunteerism by engaging individuals in meaningful, hands-on work that meets local needs and by helping charities and businesses develop their own, successful community involvement programs. People Making a Difference directly helped 16 charities and their clients. PMD partnered with these charities to plan and to complete 29 productive, high quality service projects involving 273 motivated volunteers in-person and virtually. PMD recruited 190 new volunteers who participated in the service projects described below. Together with 83 PMD volunteers who had participated in prior PMD projects, they gave 1,369 hours to complete needed work in 20+ communities. 88% (14) of the charities that PMD assisted had no staff dedicated to working with volunteers or relied on part-time staff, while the other 12% (2) received PMD assistance due to special needs. In 2023, PMD's community service program addressed the following issues: 55% Literacy (science, Braille), 21% Environment/Conservation, 10% Poverty/Hunger, 7% Youth Development, and 7% Support of Troops & First Responders. This is an equity-centered competition for high schools from New England that qualify with one or more of the following to increase NSB diversity: >75% of the students in the school qualify for free or reduced lunch; >75% of the students in the school identify as racially or ethnically underrepresented populations in STEM; and/or >50% of the students on a team would be the first in their family to attend college. 3/11 Collect/host and organize bulk seed order for Boston community gardeners. Create online system so that gardeners from 27+ community gardens could request 13,000+ bulk-ordered seed packets for The Trustees. PMD completed, organized, and hosted its 26th annual counting of packets and fulfillment of requests. 3/18 Host and officiate for first virtual Maine High School Science Bowl. Organize head-to-head, virtual competition. Recruit, train, and support volunteers who moderate, judge questions, and recognize to enable 12 teams composed of up to 5 students/team from 10 schools. Participating high schools: Bangor, Brunswick, Cape Elizabeth, Falmouth, Kennebunk, ME School of Science & Math., Mt Ararat, Sanford, The Waynflete School, and Yarmouth. 4/29 Erect fencing for conservation grazing project at Rock Meadow Conservation Area, Belmont. Volunteers educate and engage the public in composting food scraps, and recycling plastic containers and paper in order to generate less than 5% landfill waste. 9/23 Transplant & harvest bamboo for red pandas+ in the Children's Zoo at Franklin Park Zoo, Dorchester.
